**CRITERIA FOR EVALUATION (TECHNICAL / FINANCIAL):**

1. The supplier should have designed, manufactured, tested, inspected & supplied the Simplex Strainer for water applications with flow equal to or more than 1800 m<sup>3</sup>/hr on regular basis. The Supplier should have testing and inspection facility at their works.
2. The Suppliers shall furnish following documents along with SRF (Supplier Registration Form) for assessment of Supplier with reference to PQR indicated at Sl.No.- 1. above.
  - a. Supplier's Experience list for last 10 years in enclosed format- Annexure-1. Same shall be considered for PQR assessment in line with subsequent sub paras of current point 2 i.e. performance feedback certificates/ repeat order contract certificates should not be older than 8 years as on date of submission of SRF in BHEL PEM.
  - b. In support of point 1.& 2 (a), any one from i) or ii) or iii) below:
    - i). Satisfactory Performance feedback certificates from End User (in English) for at least TWO (from different customers) successfully executed contracts with Simplex Strainer, flow equal to or more than 1800 CuM/Hr which have been successfully in use for at least two years since contract execution for same industry/application, indicating salient features like Date of contract execution/ commissioning of Simplex Strainer, Duty parameter (Flow, Size etc.), PG test report, rating of project, project name etc., date of issue of certificate and name/ designation of the certificate issuer.

OR

- ii). The supplier has been awarded repeat contracts for Simplex Strainer with flow equal to or more than 1800 CuM/Hr from minimum TWO (from different customers) for same industry/ application. Repeat contract shall be considered when the second contract is given by the same customer after lapse of minimum 2 years from execution of first contract. Supporting documents for execution of the Contract viz. dispatch details, MDCC, Inspection report etc. along with the PO Copy, if supplier intends to submit the documents for Repeat Contracts.

- iii). Satisfactory Performance feedback certificates from End User (in English) for at least ONE successfully executed contract for Simplex Strainer with flow equal to or more than 1800 CuM/Hr which have been successfully in use for atleast two years since contract execution indicating salient features viz. Date of contract execution/ commissioning of Simplex Strainer, Duty parameter( Flow, Size etc.), PG test report, rating of project, project name etc., date of issue of certificate and name/ designation of the certificate issuer.
